## **Recording Release Form**

Participant fully releases LDDF and all other persons and associations, from any and all claims and causes of action that Participant may presently have or may have in the future relating to my participation in the above-mentioned Recordings, including any claims for compensation of any kind, including but not limited to royalties and commissions on sale or use of the Recordings in accordance with this agreement.
